## ASX MARKET RELEASE

### VESTING OF PERFORMANCE RIGHTS

The Board of Diversa Limited (ASX: DVA) advises that following Diversa shareholders approving the proposed Scheme of Arrangement today, in accordance with the Scheme Implementation Deed, the Board has determined that the following performance rights have now vested:

- 94,904 performance rights in relation to FY2015; and
- 122,552 performance rights in relation to FY2016.

As a result of the vesting of these rights, a total of 217,456 new ordinary shares have been issued on exchange of these vested performance rights to 15 employees, and an Appendix 3B New Issue Announcement is attached.
